#### V. Pardon Information

1. I am seeking a pardon for the convictions that relate to my actions on the night of April 8, 1988 in Dorchester. I was 16 years old at the time of my actions, though I was prosecuted and convicted in adult court. Over the past 20+ years, I have spoken openly and publicly about my actions, though the facts have sometimes been misreported in the press and on the Internet. I am deeply sorry for the actions that I took on the night of April 8, 1988, as well as for any lasting damage that I may have caused the victims. Since that time, I have dedicated myself to becoming a better person and citizen so that I can be a role model to my children and others.

The essential facts of my convictions are as follows: At around 9 p.m., I attempted to steal two cases of alcohol from a man named which was mot far from my family's home. I hit is not the head with a wooden stick that I was carrying. I then ran down the block in order to avoid law enforcement. While attempting to avoid the police, I punched a man named is not in the face. I was detained by police a few minutes after that. While I was detained, the police discovered that I had a small amount of marijuana in my back pocket. During the incident, I was under the influence of alcohol and narcotics. From later accounts of the incident, it is my understanding that I may have caused serious injuries to and/or is and/or is and/or in the face.

Although I was a juvenile when I committed the offenses described above, I was ultimately tried and convicted as an adult.

I was initially charged as a juvenile in Dorchester District Court on April 11, 1988. The charges were Assault & Battery, Assault & Battery by a Dangerous Weapon, and Possession of a Class D Controlled Substance. I was appointed an attorney named Francis Quinn. On August 10, 1988, without a formal transfer hearing, the charges were transferred to adult court. On October 14, 1988, I entered a plea of not guilty. That same day, the trial court judge entered a verdict of guilty based on a finding that I had admitted facts sufficient to sustain the charges against me. Although I had the right to appeal the trial judge's verdict and be tried by a jury, I did not do so. The trial judge sentenced me to 2 years' imprisonment at the Plymouth House of Corrections, with 3 months to be served and the balance suspended. I believe that I ultimately was released from prison after 45 days served.

Separately, I was prosecuted in Suffolk Superior Court on two counts of criminal contempt, in violation of M.G.L. ch. 12, sec. 11J. This prosecution started immediately in adult court, rather than being processed through juvenile court, under the Supreme

Judicial Court's ruling in *Doe v. Commonwealth*, 396 Mass. 421 (1985). The charges were based on the fact that I violated a civil injunction that I agreed to have entered against me when I was 15 years old. The trial judge found me guilty of these two criminal contempt counts, and I received a sentence that ran completely concurrent with the sentence I received in Dorchester District Court.

6. For the past 20+ years, I have been in the public spotlight, first as a musical artist known as "Marky Mark," then as a film and television actor, and finally as a film and television producer. In addition, I am an entrepreneur, including as a founder and an owner of Alma Nova, an Italian-Mediterranean restaurant in Hingham, and Wahlburgers, a gourmet hamburger restaurant featured on an A&E television series that began in Hingham, has opened in Canada, and is expanding nationwide. Finally, I have dedicated a substantial amount of time, energy, and money to philanthropic efforts, including the Mark Wahlberg Youth Foundation, which is based in Newton, Massachusetts.

It could have turned out dramatically different for me. Despite having two loving parents, by the time I was a teenager I had dropped out of school and gained a juvenile rap sheet. From ages 13 to 16, my decisions got progressively worse, culminating in the events of April 8, 1988. Had I stayed on that path, I would likely have ended up like so many of my childhood friends from Dorchester: dead or in prison for a prolonged period of time. Fortunately, through faith, hard work, and guidance from some incredible mentors, I turned my life around.

Rather than ignore or deny my troubled past, I have used the public spotlight to speak openly about the mistakes I made as a teenager so that others do not make those same mistakes. I have also donated money — and, more importantly, my time and energy working on philanthropic causes that help young people succeed in the face of adversity. In 2001, I started the Mark Wahlberg Youth Foundation, which has raised approximately \$9.6 million. \$7 million already has been distributed to various youth causes, including approximately \$2.5 million to Boston-area causes. I have remained extremely active in the Boys & Girls Club - in particular the Dorchester facility, where I serve as a board member and try to interact with club members as often as I can — and routinely help the organization raise money and public awareness. And I was formerly the Taco Bell Foundation for Teens "Graduate to Go" Ambassador, helping to convince unprivileged youth to graduate high school and pursue their college education. There are numerous other organizations to which I have donated my time and money, including financing a Boston-area's parish renovation of its gymnasium. Some of this has been covered by the news media, though much of it has not. I have also tried to give back to the Boston community and economy by locating film and television shoots in the area whenever possible. More privately, I make it a point to attend church nearly every day.

I have not engaged in philanthropic efforts in order to make people forget about my past. To the contrary, I want people to remember my past so that I can serve as an example of how lives can be turned around and how people can be redeemed. I also find continued inspiration in the young people that I meet. In fact, the teens that I met through the Taco Bell Foundation helped to inspire me to go back to school and finally gain my high school

diploma at age 42 from Snowden International in Boston (formerly known as Copley High School), which I consider one of the greatest achievements of my life and one of the greatest lessons I could give my own children about the importance of education.

So, why am I seeking a pardon? Why isn't it enough that I have personally risen above my past, found success in Hollywood, have served as a local and national philanthropist, and am the father of four beautiful children with my incredible wife

The easiest answer is that my past convictions still legally impact me to this day. For example, my prior record can potentially be the basis to deny me a concessionaire's license in California and elsewhere. If I were to receive a pardon, however, I generally could not be denied a concessionaire's license on the basis of my prior record, an important consideration given my personal involvement in various restaurant ventures. In addition, I have become close with many members of the local law enforcement community in Boston and Los Angeles, including as a member of the board of directors of the L.A. County Sheriff's Youth Foundation, which is dedicated to helping at-risk youth. But, given my prior record, Massachusetts and California law prohibit me from actually obtaining positions in law enforcement. If I were fortunate enough to receive a pardon, I would have the ability to become more active in law enforcement activities, including those that assist at-risk individuals.

The more complex answer is that receiving a pardon would be a formal recognition that I am not the same person that I was on the night of April 8, 1988. It would be formal recognition that someone like me can receive official public redemption if he devotes himself to personal improvement and a life of good works. My hope is that, if I receive a pardon, troubled youths will see this as an inspiration and motivation that they too can turn their lives around and be formally accepted back into society. It would also be an important capstone to the lessons that I try to teach my own children on a daily basis.

## MARK WAHLBERG PROFESSIONAL BIOGRAPHY

Mark Wahlberg earned both Academy Award<sup>®</sup> and Golden Globe nominations for his work in the family boxing film *The Fighter* and Martin Scorsese's acclaimed drama *The Departed*. Mr. Wahlberg has played diverse characters for filmmakers such as David O. Russell, Tim Burton and Paul Thomas Anderson. His breakout role in *Boogie Nights* established Wahlberg as one of Hollywood's most sought-after actors.

Mr. Wahlberg's film career began with Renaissance Man, directed by Penny Marshall, and The Basketball Diaries, with Leonardo DiCaprio, followed by a star turn opposite Reese Witherspoon in the thriller Fear. He later headlined Three Kings and The Perfect Storm, with George Clooney, and The Italian Job, with Charlize Theron. Mr. Wahlberg then starred in the football biopic Invincible, with Greg Kinnear, and Shooter, based on Stephen Hunter's best-selling novel "Point of Impact." Mr. Wahlberg reunited with The Yards director James Gray and co-star Joaquin Phoenix for We Own the Night, which he also produced. Most recently, Mr. Wahlberg collaborated with Pain & Gain director Michael Bay for Transformers: Age of Extinction. Mr. Wahlberg's additional credits include 2 Guns, with Denzel Washington, Peter Berg's Lone Survivor, The Lovely Bones, The Other Guys, Contraband and Ted.

As a film and television producer, Mr. Wahlberg produced *The Gambler*, *Lone Survivor*, *Broken City*, *Contraband*, *The Fighter* (for which Wahlberg was nominated for an Oscar® for Best Picture) and *We Own the Night*. For television, Mr. Wahlberg executive produced HBO's "Entourage" through its eight-season run and an upcoming feature film. In addition to "Entourage," Mr. Wahlberg executive produced HBO's "Boardwalk Empire," "How to Make It in America" and "In Treatment," as well as A&E's "Wahlburgers." For his work in television, Mr. Wahlberg has received a BAFTA, a Peabody, five Emmy nominations, six Golden Globe nominations, and a Golden Globe Award for "Boardwalk Empire."

Among Mr. Wahlberg's documentary work is the 2004 film *Juvies*, for which Mr. Wahlberg was an executive producer and narrator. Telling the story of twelve juveniles tried and convicted as adults and sentence to prison in Los Angeles, *Juvies* was awarded Best Documentary at the 2004 Beverly Hills Film Festival.
