10       An Act relating to schools; directing the State Board  
11       of Education to adopt a certain United States History  
12       program and assessment; requiring United States  
13       History courses to include the study of certain  
14       documents; allowing teachers options for teaching the  
15       documents and including other documents, readings and  
16       materials; listing the documents; describing manner  
17       of teaching of certain documents; amending 70 O.S.  
18       2011, Section 1210.703, which relates to financial  
19       incentives awarded to schools under the Oklahoma  
20       Advanced Placement Incentive Program; prohibiting the  
21       awarding of grants or expenditure of money for any  
22       Advanced Placement United States History course until  
23       certain conditions are met; providing for  
24       codification; providing an effective date; and  
      declaring an emergency.

20   BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21       SECTION 1.       NEW LAW       A new section of law to be codified  
22       in the Oklahoma Statutes as Section 11-103.12 of Title 70, unless  
23       there is created a duplication in numbering, reads as follows:  
24

1 A. By the 2015-2016 school year, the State Board of Education  
2 shall identify and adopt a United States History program and  
3 corresponding test which school districts shall offer in lieu of the  
4 Advanced Placement United States History course and test offered by  
5 the College Board. The program and test shall not contradict or  
6 conflict with the subject matter standards for United States History  
7 adopted by the Board and shall allow for the inclusion of and  
8 complement instruction of the documents listed in subsection B of  
9 this section.

10 B. The following foundational and historical documents shall  
11 form the base level of academic content for all United States  
12 History courses offered in schools in the state, including Honors  
13 and Advanced Placement courses, and all United States History  
14 courses shall include appropriate grade-level study of the  
15 documents. Teachers may structure, organize, deliver and teach each  
16 document in a manner and order to facilitate student learning. In  
17 addition teachers may include other foundational and historical  
18 documents, readings and curriculum materials in the course  
19 instruction. The foundational and historical documents are:

20 1. The actual content of the organic documents from the pre-  
21 Colonial, Colonial, Revolutionary, Federalist and post-Federalist  
22 eras of the United States;

23 2. The major principles in the Federalist Papers;

1 3. The writings, speeches, documents and proclamations of the  
2 Founders and Presidents of the United States;

3 4. Founding documents of the United States that contributed to  
4 the foundation or maintenance of the representative form of limited  
5 government, the free-market economic system and American  
6 exceptionalism;

7 5. Objects of historical significance that have formed and  
8 influenced the United States legal or governmental system and that  
9 exemplify the development of the rule of law including, but not  
10 limited to, the Magna Carta, a complete overview of the "Two  
11 Treatises of Government" written by John Locke, the Ten Commandments  
12 and the Justinian Code;

13 6. United States Supreme Court decisions;

14 7. Acts of the United States Congress, including the published  
15 text of the Congressional Record;

16 8. United States treaties; and

17 9. Other documents, writings, speeches, proclamations and  
18 recordings related to the history, heritage and foundation of the  
19 United States, including:

20 a. the Declaration of Independence,

21 b. the United States Constitution and its amendments,

22 c. the Mayflower Compact,

23 d. the Bill of Rights,

24 e. the Articles of Confederation,

- 1 f. the Virginia Plan,
- 2 g. the Northwest Ordinance,
- 3 h. the national motto,
- 4 i. the national anthem,
- 5 j. the sermon known as "A Model of Christian Charity" by
- 6 John Winthrop,
- 7 k. the sermon known as "Sinners in the Hands of an Angry
- 8 God" by Jonathan Edwards,
- 9 l. the Give Me Liberty or Give Me Death speech made by
- 10 Patrick Henry,

3 C. The teaching of the documents listed in subsection B of this  
4 section shall not be limited or restrained as provided for in  
5 Section 24-106.1 of Title 70 of the Oklahoma Statutes. The  
6 documents shall be used for educational purposes only and not to  
7 establish or promote any religion.

8 SECTION 2. AMENDATORY 70 O.S. 2011, Section 1210.703, is  
9 amended to read as follows:

10 Section 1210.703 A. Contingent upon the provision of  
11 appropriated funds designated for the Oklahoma Advanced Placement  
12 Incentive Program, the State Board of Education is hereby authorized  
13 to award schools:

14 1. A one-time equipment and/or instructional materials grant  
15 for the purpose of providing an advanced placement course, based on  
16 criteria established by the Department. Schools which receive the  
17 grants shall:

- 18 a. offer the advanced placement courses beginning the  
19 school year following receipt of the grant,  
20 b. provide the College Board training within one (1) year  
21 of the grant award, including at least a one-week  
22 summer institute. Teachers shall be encouraged to  
23 attend annual follow-up training, and  
24

1 c. make available advanced placement examinations to all  
2 students taking the course for which a grant has been  
3 awarded;

4 2. Additional grants to school sites demonstrating successful  
5 implementation, as defined by the State Board of Education, of the  
6 courses for which the first grants were awarded. Schools may  
7 qualify for additional grants a minimum of four (4) years after  
8 receiving a grant award;

9 3. Subsidized training for advanced placement courses,  
10 preadvanced placement courses, or International Baccalaureate  
11 courses in a form, manner and time prescribed by the Department;

12 4. One Hundred Dollars (\$100.00) for each score of three or  
13 better on an advanced placement test or four or better on an  
14 International Baccalaureate examination; provided, these funds shall  
15 be used for the purpose of Advanced Placement Program development;

16 5. For those students who demonstrate financial need as defined  
17 by the College Board or the International Baccalaureate  
18 Organization, a share of the advanced placement or International  
19 Baccalaureate test fee;

20 6. For those students who take more than one advanced placement  
21 or International Baccalaureate test in one (1) year, a share of the  
22 advanced placement test or International Baccalaureate fee in a  
23 manner prescribed by the Board; and  
24



1           7. Grants for the purpose of developing an advanced placement  
2 vertical team based on criteria established by the Board.

3           B. Upon completion of the test, the State Department of  
4 Education shall obtain from the College Board and the International  
5 Baccalaureate Organization a list of students in Oklahoma who scored  
6 a three or higher on the advanced placement test or a four or higher  
7 on the International Baccalaureate test. Financial incentives for  
8 schools provided in this section shall be awarded at the beginning  
9 of the next school year following the school year in which the test  
10 was taken.

11           C. Any new expenditure authorized pursuant to Section 1210.701  
12 et seq. of this title shall be contingent upon the availability of  
13 funds.

14           D. Beginning with the 2015-2016 school year, the Board shall  
15 not award any grants to school districts or make any expenditure of  
16 state funds as authorized pursuant to this section for equipment,  
17 instructional materials, course development, professional  
18 development or training, examination awards or examination  
19 scholarships for the Advanced Placement United States History course  
20 until the College Board changes the framework for the course and  
21 reverts back to the course framework and examination that were used  
22 prior to the 2014-2015 school year.

23           SECTION 3. This act shall become effective July 1, 2015.

1       SECTION 4. It being immediately necessary for the preservation  
2 of the public peace, health and safety, an emergency is hereby  
3 declared to exist, by reason whereof this act shall take effect and  
4 be in full force from and after its passage and approval.
